



## **OWI/** Possession of Cocaine

On 10/26/2019, Officer was dispatched to a private property accident in the 30000 block of Southfield Rd. Dispatch advised a vehicle struck a brick wall at the business and was unsure if the driver was ok. Upon arrival, Officer observed subject laying on the ground, next to a curb several feet away from her vehicle. Officer attempted to speak with driver. The driver appeared to be intoxicated and stated she had "two drinks" of mixed alcohol. The driver kept on closing her eyes, as if she was falling asleep and was unable to stay awake. A Life Unit arrived on scene and transported the driver to the hospital.

Attempts to complete Sobriety Tests and PBT were negative. A search warrant and blood draw was later completed at the hospital. After the driver was medically cleared she was transported to the Southfield Jail for processing. During processing Officer recovered a zip-lock baggie and two straws with suspected cocaine. The suspected substance was submitted to the Lab for analysis.
