


Officers responded to report of an Assault just occurred at Apartment Complex in the 16000 Block of W Nine Mile Rd.

Victim came into the front desk with two of her friends to report Domestic Assault.

The Desk Officer observed dried blood on victim's pullover hoodie, a swollen lip on her left side, bruising on her nose, and numerous bruises on both sides of her neck and back of the neck. Victim had multiple abrasions and indentations that appeared to be caused by the suspects fingernails. Victim requested medical attention and SFFD Paramedics arrived on scene and treated her for her injuries.

Victim advises she was driving in the car with her boyfriend and he got upset when she didn't want to go back to his dorm with him. He grabbed her by the neck and started to strangle her and assaulted numerous times. Victim attempted to exit the vehicle but suspect wouldn't let her and he continued to assault her.

Victim attempted to call 911 with her cell phone and suspect stopped her and took her phone from her.

Suspect pulled his vehicle behind a building near their Dorms and college campus. The suspect gave victim a dark colored towel and told her to clean up before going back to her dorm. Victim fled the vehicle at this point. Victim ran back to her dorm and told two of her friends what had happened. Victim advises that her boyfriend has assaulted her numerous times in the past. Victim states herself and the suspect have a 5-month-old child in common.

According to Victim, herself and her ex had already been arguing before she went to his apartment to pick up her baby. When she got to suspect's apartment she started to gather her baby's things and when leaving he was upset and followed her to her car. After securing the baby in the back seat, R/P got into the driver's seat of her vehicle and her ex threw a water bottle at her and hit her in the back of the head. R/P threw the water bottle back at her ex. Prior to driving away her ex broke the side mirror on her vehicle.

R/P took her baby to her cousin's place. Her sister was there and she told them what had happened.

R/P and her sister returned to her ex's place with the intentions of damaging his vehicle. R/P had a knife and started to scratch her ex's car and he saw her doing it. He started to yell at her from his apartment balcony and he came outside to confront her.

As R/P was getting into her car she heard a loud pop and felt pain and pressure in her hip, saw blood, and realized her ex had shot her.

R/P's sister drove R/P to the hospital and stood by for the Police.

A Southfield Police Evidence Technician responded to the hospital and took photos of victim's injuries and gathered other evidence.

Arrest of the suspect has been unsuccessful as of 10/8/2020.

On 10/8/2020 a Southfield Detective swore to an Assault with Intent to Murder and Felony Firearm Warrant issued by OCPO.
