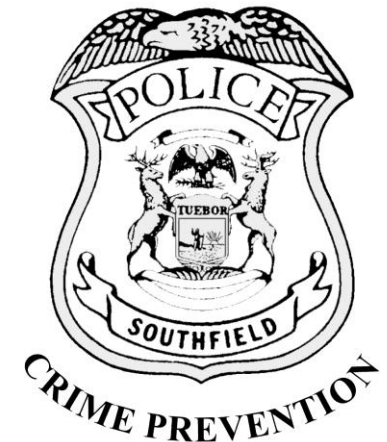

<p>09/26/2021 1:07am</p>	<p>20000 W Twelve Mile (Commercial-Cellular Repair)</p>	<p>Glass on front door was broken out with a brick.</p>	<p>On 09/26/2021 at 1:15am, Officers were dispatched to the 20000 Block of Twelve Mile Rd (Cellular Repair) reference an alarm.</p> <p>Officers arrived on scene and discovered suspects made entry by breaking glass on front door.</p> <p>Officers reviewed security footage and observed two light skinned B/M's arrive in front of the store in a vehicle that appeared to be black in color, possibly a SUV. One of the suspects could be seen throwing a red brick at the front door multiple times before the brick went through the glass. When this happened, the first suspect began kicking the front door and then shoved himself through the bottom half the of the door.</p> <p>The second suspect followed. Both suspects then entered the back room where they began grabbing cellphones off the counter.</p> <p>After leaving the backroom, both suspects ran behind the counter but did not appear to take anything and then left through the bottom half of the door.</p> <p>Suspect#1 U/M, 5'10, thin build, black hoodie and pants, black and white shoes.</p> <p>Suspect# 2 B/M, light complex, thin build, black ski mask, black hoodie with Metallica emblem on the front and back, gray sweat pants w/ white stripe down the side, brown Timberland boots.</p> <p>Investigation is on-going.</p>

It appears that 10 sets of keys were taken and several files may have been taken from the office.</p> <p>Surveillance video confirmed three suspects inside the business between 8:29pm- 8:35pm. R/P (Mother) called the Police after her 7- year old daughter came home and told her mother that a man tried to get her into his vehicle.

The 7- year old daughter stated she was riding her bike on the sidewalk near the corner of Fairfax St. and Wiltshire when a Green Van pulled next to her. Victim believes the van turned onto Fairfax St. from Wiltshire. Victim stated a black male with a gray and black goatee was driving. The male put the window down and yelled "come here baby." At the same time victim stated another car pulled up and a dark skinned black male got out and started running towards the green van. This male yelled at the driver of the van and was seen hitting the van. When asked what the male said to the driver of the green van, victim stated "what the F are you doing." While these two males were in the street, victim was running home. Victims friend who was nearby witnessed and confirmed the incident.

**Providence Dr. & W Nine Mile Rd.**

On 09-20-2021, Officers were on routine patrol when they observed a Black Dodge Charger traveling N/B on Providence. The Charger did not have a license plate or a temporary license tag on display. Officers initiated a traffic stop N/B Providence north of 9 Mile.

Upon initiating the traffic stop, Officers observed the rear passenger immediately move downwards towards the floor in the back seat displaying furtive movement. The vehicle was stopped and Officers mad contact with the three occupants of the vehicle.

The driver had warrants and the occupant that was displaying furtive movement was requested to exit the vehicle. The occupant complied and stated, "there's a gun in the car". Officers secured this passenger and a handgun was recovered under the passenger front seat.

The passenger displaying furtive movement was taken into custody for CCW.

**Special Attention: Larceny from Vehicles**  
**How to prevent this from happening to you!**

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

-After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle as close to your residence as possible.

-If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers

**16000 Block of North Park Dr.  
(Apartments)**

On 09/20/2021 at approx. 10:03am, Several Southfield Officers, responded to the area J.L. Hudson/Providence Dr. for shots heard. It was also reported the gun shots took place in front of a Day Care in the 15000 Block of J.L. Hudson Dr. Southfield Police Dispatch received a call from the Daycare Center stating one of their windows was hit with a bullet. Officers arrived into the area secured the scene and began interviewing witnesses.

One eyewitness told Officers he heard a vehicle squealing its tires and a vehicle engine revving loudly to accelerate near Providence Dr. Witness looked towards the area of J.L. Hudson/Providence Dr and saw a Gray Vehicle being pursued by a White Jeep Cherokee. As the vehicles traveled westbound on J.L. Hudson, a black male in his mid-20s, low-cut hair wearing a coral colored t-shirt, opened the rear driver side door of the gray vehicle and produced a handgun. The male began firing multiple shots toward the White Jeep Cherokee. It was later discovered that there were two suspects involved in this shooting. Fortunately, no one was injured in this incident.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

-Citizens should always be mindful not to leave anything of value in their vehicles. Especially wallets, purses, cash, handguns, cell phones, laptops, jewelry, or anything else of value. If you must leave your handgun in your vehicle it should be kept in a gun lock box that is bolted down in the trunk of the vehicle. At the very least you should try to hide the handgun somewhere that it would be difficult to find. The first place that criminals will look is under the front seat, in the center console or in the glove box.
