



Special Attention: Fleeing & Eluding 09/29/2020 8:45pm

W Eight Mile Rd. & Shiawassee Rd.

Southfield Officer was on routine patrol traveling E/B 8 Mile Rd, East of Berg Rd. when he observed a Light Green Dodge Charger without a license plate and a Burgundy Dodge Charger traveling closely behind it with a Michigan License Plate attached to rear of vehicle.

Both vehicles were late model Chargers equipped with Hemi V8's. A LEIN search of the plate on the Burgundy Charger revealed that it was a stolen license plate. Reported out of Southfield.

A traffic stop was initiated on the Burgundy Charger and when Officer activated his overhead lights both vehicles fled s/b on Five Points from Eight Mile Rd at a high rate of speed. No pursuit was initiated by Officer.

Vehicle was entered in LEIN as Felony Vehicle. **Note:** In the original Southfield Incident, a Blue 2019 Dodge Charger Scat Pack was stolen from garage in the 16000 Block of North Park Dr. The vehicle was later recovered with the plate missing. This would be the plate that was on vehicle that fled from Southfield Officer in this most recent incident.

Southfield Officers responded to a personal injury accident on Southfield Rd. just south of W Ten Mile Rd. It was reported that one of the drivers walked away from the accident scene. Officers arrived on scene and located the drivers. The one that walked away seemed confused and refused medical attention. When Officers asked for his driver's license, it was discovered that it was suspended. Officers were given permission to retrieve the registration and proof of insurance from the glove compartment. When Officers opened the passenger side door, they observed a black handgun on floor of the front passenger seat. The driver was asked if he has a CPL and responded "no". It was confirmed that this driver didn't have a CPL. He was taken into custody for DWLS & CCW.

Special Attention: Shooting

10/02/2020 6:46pm 25000 Block of Shiawassee

(Apartments)

Southfield Officers responded to a report of shots fired. The investigation revealed that a mother and son were arguing. The son went outside and fired two shots in the parking lot and fled the scene. The mother was completely uncooperative and refused to tell Officers who her son was.

Officers located a blood trail that started in the parking lot and led them to apartment where witnesses stated the problem was at. Officers made entry into the apartment to make sure there were no persons injured or required medical attention. No injured person(s) were located. Officers identified the son and contacted him via phone. He confirmed that he and his mother got into an argument and he punched his TV in his bedroom and damaged the TV. He left his mother's apartment and grabbed a handgun out of his vehicle. He stated that he accidentally discharged the gun a single time while it was pointed upward toward the sky. He then attempted to unload the magazine and accidentally discharged the gun again up into the air. The subject refused to meet with Officers in person to discuss incident any further. A Southfield Police Evidence Technician processed the

scene and collected evidence.

Suspect has been identified and incident is under investigation.

MDOP/ A&B- 1- Arrest 10/03/2020 3:53pm

17000 Block of Lee St.

On 10/03/2020 Southfield Officers responded to the 17000 Block of Lee St. on a report of a Domestic Disturbance. Investigation revealed that suspect, former boyfriend came into R/P's house w/o permission yelling and screaming. It was reported that the former boyfriend got very aggressive when asked to leave. Witness (R/P's son) stated that suspect pushed R/P so he intervened and got in between them and suspect assaulted him. The situation then escalated to witness and suspect getting into a physical confrontation. The male suspect had called 911 and reported that the female had a gun. This was unsubstantiated. The male subject was taken into custody for MDOP, (punched holes in the wall), A&B v's R/P (ex-girlfriend) and A&B v's witness who intervened when R/P was being assaulted.

Special Attention: Possible Accidental Shooting

(Hotel)

Several Southfield Officers responded to report of a shooting in the 27000 Block of Northwestern (Hotel). R/P advises he was asleep in his room when a gunshot woke him up. When he woke up, he noticed multiple holes in his wall. He heard one gunshot and thinks the bullet bounced off the ceiling after entering through the wall. R/P was not injured from this incident.

Officers determined that a single shot was fired from one specific room into R/P's Room. The room that the shot came from was checked for occupants and none were located. Officers obtained information as to who rented the room that the shot came from. This person has been identified but was not located at time of report. A Southfield Police Evidence Technician responded and processed the scene.

Special Attention: Larceny of Mail 29000 Block of Heritage Ln.

Multiple residents on Heritage Ln. have had mail stolen from their mailbox.

Southfield Officer attempted to stop a vehicle for travelling well above the posted speed limit and reckless driving. The driver initially stopped for Officer who was in a fully marked police vehicle with overhead lights activated and was in full uniform and when Officer approached on foot the driver recklessly fled from the traffic stop. The driver later came into the police lobby to make a complaint against Officer for trying to stop him? How to prevent this from happening to you!

Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package.

Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

-Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)

- If you have a garage you should park your vehicle in the garage and lock the garage.

- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.

Southfield Officers were dispatched to the area of Lahser Rd and 11 Mile Rd on the report of a slumped driver. Dispatch advised the driver was asleep at the intersection while operating a Grey SUV.

Upon arrival Officers observed a Chevy Equinox stopped at the green light n/b Lahser Rd at 11 Mile Rd. Upon approaching the vehicle Officers observed the driver asleep behind the wheel of the vehicle. The vehicle was running and in gear. Officer had to knock on the driver side window and shake the car multiple times to awake the driver.

When the driver awoke she was very disoriented and Officers had to instruct her multiple times to put the car in park and to turn off the vehicle. Officers could smell a strong odor of intoxicants coming from the vehicle. The driver was given sobriety tests and a PBT test. PC was established and the driver was taken into custody for OWI. -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle as close to your residence as possible.

-If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.
