27000 Block of Shiawassee Rd.

Victim stated that his friend picked him up from work at 7:30pm. Before taking victim home, they stopped at the liquor store in the 27000 Block of Shiawassee Rd. in Southfield. When the two exited the store, victim heard someone call his name from a house just across Shiawassee Rd. Victim walked across the road without his friend who stayed in the car. When victim reached the front porch of the residence, he was confronted by approx. 6 white males and 1 white female. Victim recognized one of the subjects. Two unknown males, possibly boys that he goes to school with pushed victim onto the ground. The group of approx. 6 males began to punch and kick him while he was on the ground. The males "stomped" on victims head several times. The group of males then said, "run his pockets!" and they searched the pockets of his pants for items. Victims phone and wallet were inside the pockets of his jacket and were never taken. The incident occurred in about 45 seconds according to victim. The female, was yelling at the males to stop. Victim was unsure why the males attacked him and was unable to positively identify all of them. Victim recognized the group from his High School where he is currently enrolled in the 12th grade.

Officers met with the victim who had obvious injuries to her face. She was unable to articulate complete words/sentences due to her injuries. A Southfield Police Evidence Technician took photos of victim's injuries.

Investigation revealed that victim was beat up and physically abused by her mother, her aunt and her cousin because she skipped school. Victims injuries were extensive. Victim had significant trauma to her head & face.

One suspect was arrested for Aggravated/ Felonious Assault.

Photos were also taken of abrasions on the suspects hands.

Victim's mother and aunt were later interviewed by Detectives and the incident is under further investigation.

On 10/05/2019 Officers were dispatched to the area of the 26000 Block of Berg Rd (Apartments) regarding a Subject Armed.

Security from Apartment Complex advised the subject was on his cell phone arguing with someone. He appeared to be intoxicated and he had a black handgun with an extended magazine.

Officers arrived on scene and located the subject on Berg Rd. near Simmons St.

Officers assisting with the investigation recovered a pistol without a magazine in the S/B lane on Berg north of Hooper Blvd. It was a match to the magazine recovered from the suspect. The serial number on the pistol was scratched off.

Officer was in the area and was observing traffic leaving the apartment complex. He observed a Blue Chrysler 200 hurriedly leaving the complex. The vehicle was occupied by a female wearing a hooded sweatshirt. The hood was pulled over the woman's head. The vehicle headed S/B on Lahser towards W Eight Mile. The vehicle cut through a gas station parking lot and proceeded W/B on Eight Mile Rd. at a high rate of speed.

Officer caught up with the vehicle on W/B Eight Mile near Telegraph. The female driver looked in her rear-view mirror several times as she approached Telegraph. Officer activated his lights and siren and attempted to stop the vehicle. The driver ignored Officers attempts to stop the vehicle and attempted to flee from Officer.

The vehicle entered the parking lot of Bar located in the 24000 Block of Grand River. The female driver exited the vehicle with a small child and fled into the bar with the child.

Officer pursued the woman on foot. The woman was apprehended inside of the galley of the bar.

The woman was taken into custody for Fleeing & Eluding. It was later determined that the suspect had stabbed her husband with a pair of scissors. The suspect was also charged with F/A Domestic.

The child was unharmed during the incident and later turned over to suspects mother.
