


Home Invasions Occupied Dwellings (North of 8 mile, South of 9 mile between Southfield Rd & Lasher Rd.)

There have been 4 Home Invasions in the past two weeks that occurred in the early morning hours of occupied dwellings. The occupants at each residence were awakened by loud noises from the suspect attempting to break in.
