


Several Southfield Officers were dispatched to the area of the 28000 Block of Marshall on the report of a male subject looking through the window of the residence. The subject fled the location and was being followed by a witness. The subject crashed his vehicle in the area of Balewood and fled on foot. Witness stated he saw a thin black male, approx. aged 23-30, wearing a black shirt and khaki shorts and flip flops exit the crashed vehicle and run south. Officers conducted an inventory search of the vehicle and located paper work that contained the name of a person that is believed to be involved in several Peeping Tom Incidents.

The suspect vehicle was impounded and this and other incidents are under further investigation.

(Apartments)

All parties involved advise they entered the apartment complex and entered their apartment building. As they were walking down the hall to their apartment they noticed suspect who is known to them behind them, walking toward them with a pistol, pointing at them. One of the victims got to the door and began attempting to unlock and open it. A person inside the apartment opened the door for them. They entered the apartment and attempted to shut the door. Suspect held the door open and forced his way into the apartment. They tried to shut the door to prevent him from entering but he made entry.

There was a commotion between everyone on what suspect was doing there. Suspect was pointing his pistol at all parties during this confrontation.

Suspect told one of the victims to get down on the ground. He refused to get down. Suspect pistol whipped this subject on the front of the head, knocking him to the ground and causing a laceration. When contact was made with the bottom of the weapon to victim's head, a round was discharged into the ceiling.

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.

-If you don't have a garage, try to park your vehicle

Possession of Marijuana/ Open Intox., R&O-

Officers were dispatched to the 25000 Block of Evergreen Rd. (Gas Station) on a report of a slumped subject behind the wheel of their vehicle.

Officers located the subject, he was passed out and the vehicle wasn't running. After numerous attempts to awaken the driver he woke up. He was obviously intoxicated. Officers observed in plain view a bottle of liquor the was half consumed and a scale in the interior of the vehicle. When the driver exited the vehicle, there was a plastic bag protruding from his underwear. Officers grabbed the plastic baggie and there was a quantity of suspected marijuana in it.

When Officers attempted to identify the subject, he gave Officers false information about his identity.

A Southfield Police Evidence Technician Field Tested the suspected substance. It tested positive for possible presence of marijuana. The subject was taken into custody for Possession of Marijuana, Open Intox., & R&O.

as close to your residence as possible.

-If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

-Lots of lighting around the area(s) that you park your vehicles is also very beneficial. Criminals don't like to work in well lighted areas. They prefer to work in darkness because it's difficult to see them.

Possession of Marijuana/ R&O- 1- Arrest

Officers observed vehicle commit several traffic violations. When Officers attempted to get in behind the vehicle to stop it, the driver slowed down to avoid Officers.

Officers eventually got in behind the vehicle and stopped it.

After approaching the vehicle Officers could smell a strong odor of marijuana coming from the interior of the vehicle.

When Officers attempted to remove the occupants from the vehicle the passenger refused to exit the vehicle. When Officers attempted to remove subject he physically resisted. He was taken into custody for R&O. During the search incident to the arrest Officers recovered a plastic baggie containing suspected marijuana from suspects pocket. The driver was cooperative and was released at the scene.

A Southfield Police Evidence Technician Field Tested the suspected marijuana. It came back positive for possible presence of marijuana.

Special Attention: Larceny of Packages that were ordered and delivered via Common Carrier. How to prevent this from happening to you! Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.
