


From: 08/14/2017 5:00pm To: 08/15/2017 7:00am	21000 Melrose Ave. (Commercial- Medical)	Suspect pried the bottom of a bay delivery door (S/E) to gain entry to the business. Suspect slid under the pried door approx. 20 inches of space.	Investigation revealed that sometime between 5:00pm and the following morning at 7:00am suspect(s) pried the bottom of a bay delivery door (S/E) to gain entry to the business. Suspect then slid under the door. (approx. 20 inches of space) Suspect entered the unlocked office area and stole the Cash Register that contained assorted bills. Suspect also climbed through ceiling tiles to enter a storage room containing donated medicines (non-narcotic). No items were disturbed in the locked room and no items appear to be missing.
08/18/2017 12:37am	28000 Telegraph Rd. (Commercial- Electronics)	It is believed that suspect hid inside the store when it was open for business.	Officers were dispatched on an alarm at business at 12:37am. The business checked secure at that time. Workers arrived at business at approx. 7:50am and discovered that a cage with merchandise was forced open and several electronic items were taken. There was no force located on any of the entry doors for business. It appears that suspect may have hidden inside the store when it was open for business. Video surveillance from inside the store shows at 12:37am suspect pushing a ladder to the raised locked cage area containing electronic items. Suspect cuts the lock with a pair of bolt cutters and loads several items in a plastic bag. Suspect then fled toward the S/E emergency door and trips the store alarm. A Southfield Police Evidence Technician processed the

scene, collected evidence and recovered the suspects bolt cutters that were used for cutting the lock.

Bag with wallet and Prescription Drugs/ Pills.	<p>Victim states he was walking north on the west side of Telegraph back to his apartment when he walked by a group of B/M's. They started asking him questions about where he was coming from and where he was going. Victim kept walking north and the suspects eventually surrounded him and forced him to stop walking. The main aggressor told him to hand over his bag that contained several items.</p> <p>Victim stated he had no choice but to hand over his bag. Victim states he was never actually struck in any way they just grabbed his arms and were reaching in his pockets. The suspects took off running towards Franklin Rd through the construction area.</p> <p>After the robbery occurred victim went to a nearby Hotel and had someone from the Hotel call the Police.</p> <p>Victim stated he didn't recognize the guys but was concerned because he had prescription pills in his bag that he would be needing.</p> <p>Suspect's Description: Suspect#1 was described as a B/M, early 20's, 5'10", medium build, goatee, red shirt and black pants. Suspect#2 was described as a B/M wearing a navy-blue shirt with a design on the front of it. The other 2 suspects were described as B/M's</p>

			wearing white t-shirts. Victim stated he was unsure how many people there were total because they surrounded him and never could get a definite count of how many people were involved.

Victim states he was pulling into his condo complex and looked in his rearview mirror to see a silver minivan enter behind him. There is a gate at the entrance of the complex that victim entered a code to open. Victim thought the van was going kind of fast and thought it was weird when it entered the complex right after him without putting in a gate code. As victim was walking to his condo suspect walked up behind him and was armed with a handgun. The suspect told him to be quiet. Victim hit the ground, rolled, got up and started running towards the front of his complex. When victim got to the front of the complex he saw the silver van that had followed him into the complex. The van was flashing its lights off and on and was now driving towards victim. Victim fearing for his safety states he removed his handgun and fired several shots into the air to scare whoever was in the van away. The van was last seen driving out of the complex onto Shiawassee St. Victim described the suspect as a B/M wearing a black hoodie, jeans, a mask covering the bottom

Officers arrived and went back to victim's vehicle and together with the victim they located his sandals he was wearing that came off when he was running. They also located his keys, glasses, cell phone and some cash. Victim states he is missing cash and a pair of shoes. Victim does have a CPL and the handgun is registered.</p>

When victim caught up to the subjects one of the subjects kicked him in the stomach. The unknown subject had short black hair, red and white black shorts and red and white shoes. Victim was unable to get the make or the model of the vehicle or a description of the other b/m.

Be on the Look Out Highlights:**Arrests by SPD Officers:**

Special Attention: Continuing to see Home Invasions in Area 13, specifically north of Catalpa in the 28000 Block of Everett, Marshall, Brentwood, Fairfax & Sutherland. This past week there were two more Home Invasions reported in this area.

1)28000 Block of Brentwood

Occurred on Thursday between 5:30am- 3:00pm
Entry was by pushing in air conditioning unit.
Flat Screen TV and a Handgun were taken.

2)28000 Block of Aberdeen

Occurred on Sunday between 9:30am- 2:12pm while victim was at church.
Entry was through Kitchen window.
Suspect(s) retrieved a shovel from victims shed and used it to break out the window.
Flat Screen TV and a Bracelet were taken.

Note: This is the same M.O. of numerous Home Invasions in this area. Most of the entries are through a rear window, door or the side door. Most of the Home Invasions have occurred during the daytime and early evening hours and in the 28000 Blocks of Fairfax, Everett, Marshall, Brentwood & Sutherland. (North of Catalpa)

There has also been one in the 16000 Block of Catalpa and one on Lexington Pkwy.

Looking back over the last few months witnesses have reported the following:

-A B/M in a Red Boxy Style Van was seen parked near one of the residences.

-A Newer White Vehicle was scene parked in the driveway at one of the residences.

-A witness saw a Small White Vehicle sitting in front of residence. Witness saw a B/M 25-30, 5'-8" to 5'-10", 160- 180, med. comp, short afro, dressed in black, exit the vehicle and walk between the houses. Witness however didn't call the Police.

-Witness advised that a B/M, bald, wearing a red sweat shirt and jeans approached witness and asked if anyone lived at the residence. The suspect was last seen standing in front of the attacked residence.
