On the listed date and time, Officers were dispatched to the 25000 Block of Pierce on a report of a possible Attempt Abduction involving a 12 year old child. The victim stated that he was walking home from school in the area of Southwood and Sherfield Pl. when he noticed that a Black Dodge Ram Pickup appeared to be following him. The victim stated that the driver of the vehicle asked him to get in the vehicle and he refused. The victim stated that the passenger exited the vehicle and grabbed the hood on his sweatshirt and attempted to pull him towards the vehicle. The victim was able to pull away from the suspect and escape on foot. The vehicle and suspects left the area in an unknown direction.

Southfield Officers were patrolling in the area of Greenfield and 9 Mile Rd when they observed a Four Wheel ATV driving on the street without a license plate or proper lights. The 4 wheeler was also observed driving N/B in the S/B Greenfield Rd lanes when they were attempting to turn around to initiate traffic stop.

Officers activated their lights and siren. The driver looked back and then accelerated away from Officers S/B through the Art Van parking lot, over the curb, onto E/B Foster Winter Dr. to N/B Greenfield Rd. While travelling N/B Greenfield the driver was travelling in excess of 60 mph at times in a 40 mph zone, cutting across lanes, and cutting off traffic. The driver then turned E/B on Oak Park Blvd into Oak Park. The driver was travelling E/B disregarding all stop signs from Greenfield Rd to Church St. The driver then left the roadway and began driving through a Park. After driving over a large hill, there were several other units approaching, which caused the driver to stop fleeing. The driver was taken into custody for Fleeing & Eluding.

A Southfield Police Evidence Technician Field Tested a sample of the suspected substance that was confiscated. The result was positive for possible presence of Heroin.
