


Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you hear any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach or Scare the Suspects Away) give Police Dispatchers

Southfield Officer was on routine patrol in the 25000 Block of Shiawassee, ran license plate on vehicle leaving the apartment complex. Two warrants came back for the owner of the vehicle. Officer stopped the vehicle and upon approaching the vehicle immediately observed a handgun lying on the back seat behind the driver. Officer immediately ordered the driver and passenger to put their hands on the dash. The driver stated he had a permit for the handgun and the gun wasn't loaded.

Additional Officers arrived on scene to assist.

Further investigation revealed that the driver didn't have a CPL and his Driver's License was Suspended.

The driver was arrested for DWLS & CCW.

When searching the driver Officers recovered a loaded magazine for the handgun. as much information about the suspect(s) and suspect vehicles as you can. Stay on the phone with Dispatchers until the Police arrive.

Southfield Officers responded to report of a Male Assaulting a female out in front of the residence.

1- Arrest

The male subject was last seen dragging the female into the residence. Officers arrived and attempted to make contact at the residence.

B/M subject answered the door, but would only open the door slightly. He refused to let the Officers into the residence to check the welfare of the female that was dragged into the house.

The subject attempted to close the door. Officers had to force their way into the residence. Subject resisted Officers as they attempted to secure him.

Officers located the female victim. When Officers attempted to interview her male subject interfered with Officers investigation coaching her on what to say and then told her not to say anything. Officers took a statement from the original caller that witnessed & reported incident.

The male subject was taken into custody for Resisting & Obstructing at this time.

Officer's investigation eventually identified the subject's true identity. Officers returned to the vehicle to arrest driver for DWLS and Obstruct Police. The driver refused to exit the vehicle and locked the doors. He stated he didn't recognize their Government Agency. (Sovereign Citizen)

The passenger door was open and Officers were able to unlock the doors. The driver was then taken into custody.

Officers were dispatched to 27000 Block of Northwestern (Hotel) for a subject armed. Southfield Dispatch advised Officers the R/P, called stating a female in the parking lot was holding a knife and threatening her. Dispatch also stated the armed female slashed one of R/P's tires already.

Officers arrived on scene located subjects involved and conducted an investigation.

Investigation led to the arrest of one of the female combatants for F/A with a Knife and MDOP to victims vehicle. (Tire slashed and flattened) A Southfield Police Evidence Technician processed the scene collecting evidence and taking photos.
