



Upon arrival, Officers were advised by the home owner that she heard a crashing sound and observed 3 males attempting to force the door open on residence. Damage was observed and Officers observed two males in the area. A K-9 track was initiated by a Southfield K-9 Officer. K-9 eventually flushed out the suspects from where they were hiding and they were observed by Officers on the perimeter crossing over 8 Mile Rd. into Detroit. Two suspects were located and taken into custody. K-9 continued to track and a third suspect was later taken into custody after a foot pursuit. K-9 also located several articles of clothing and a backpack that suspects had discarded during their attempt to escape. It appears that the suspects involved in this Home Invasion may be the same as the suspects in the earlier Home Invasion in the 18000 Block of Westhampton and also the Home Invasion in the 21000 Block of Avon Ln.
