


After running the plate on suspect vehicle, it was discovered that the vehicle and registered owner were involved in a R/A- Home invasion which occurred in Southfield earlier in May of 2018. (Suspect is known) Surveillance video shows one of the suspects dropping known suspect and another unknown suspect off at victim's apartment complex and the third suspect parks vehicle at the front door and stays in the car. Known suspect and unknown suspect then go to

victim's apartment and knock on the door. After nobody answers the door known suspect is observed forcing the apartment door open with his shoulder. Both suspects enter the residence at approx. 4:29pm. They then quickly exit due to an audible alarm sounding. Per the victim they were not able to steal anything.

Both suspects then flee to the awaiting vehicle with third suspect and leave the property.

Suspect#1 Known suspect was positively identified in the surveillance video.

Suspect #2 who was in the car while suspects broke into victim's apartment was identified as a subject known to the victim.

Suspect#3 was identified as an accomplice who was with known suspect on earlier R/A- Home Invasion that occurred in May 2018.

On 06/20/2018 known suspect was arrested in another jurisdiction.

At the time of his arrest he was with a subject that was later identified as the third suspect in this Home Invasion.

This incident is under further investigation for complaint and warrant against all three suspects.

Pharmacy B&E's are on the rise in Southfield and in other communities. 23000 Block of Southfield Rd.

Two Incidents recently at Southfield Pharmacy in the 23000 Block of Southfield Rd.

The location is a Pharmacy attached to an Urgent Care. Two attempts have been made by suspects to gain entry into the pharmacy section of the building. First attempt was on Sunday 06/10/2018 at 6:00am. Second incident occurred on Sunday 06/24/2018 at 5:00am. In both attempts the outer doors were pried open allowing entry into the building. In both incidents the suspects were unable to retrieve anything.

Home Invasion & Larceny of AC Units Apartment/ Townhouse Complex 17000 Block of Violet Dr.

The location is an Apartment/Townhouse Complex at Southfield Rd and Webster Ave. Part of the complex has new construction and the ac units were targeted. Also one of the homes that was furnished was broken into and appliances were taken. Home Invasion occurred between 06/15/2018 and 06/19/2018 unknown time.
