


Special Attention- MDOP/ Shots Fired at Business

06/25/2019 10:49pm 22000 Block of Telegraph Rd.

(Gas Station)

Several Officers responded to shots fired in the 22000 Block of Telegraph (Gas Station) suspect left w/b on 9 Mile Rd.

Officers arrived on scene and reviewed surveillance video. Officers observed a B/M and a W/M inside the store purchase items. The two subjects then exited the store and approached an Older Model Teal Chrysler Town and Country parked in the parking lot. Officers observed the W/M put items on the passenger seat of the vehicle. Officers observed the B/M go around the vehicle and enter the driver side. Once the B/M was seated in the driver's seat he reached down to the right of the seat and pulled up what appeared to be a handgun. The male can be seen playing with the gun while seated in the driver's seat. The male can also be seen pointing it in many directions, and at one point towards the store. It is believed that the gun somehow discharged during this time.
