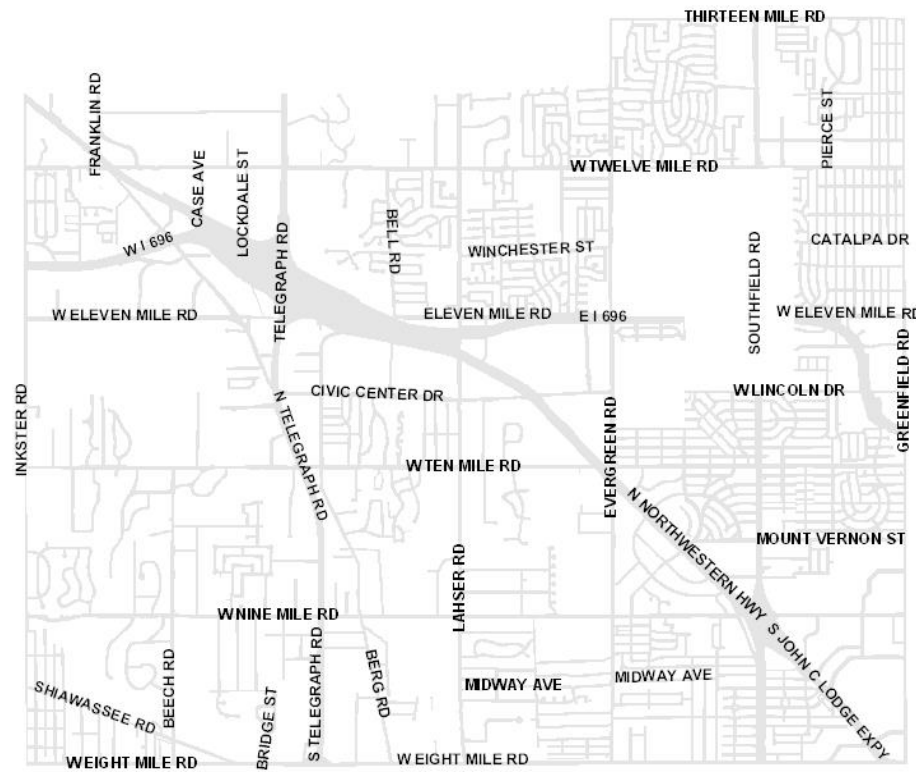

The suspects are unknown males with one wearing a blue hooded sweatshirt and the second wearing a tan hooded sweatshirt. Unknown amount of money was in the cash register.</p>

Victim went downstairs. He was approached by 2 B/M's on the way to the main office and had a verbal altercation with them.

Victim states as he was walking near the pool he was assaulted by the two B/M's and his glasses and headphones were knocked to the ground.

One of the B/M's took his headphones.

There was a third subject (not involved in Robbery) that later came up to victim and offered him an undisclosed amount of cash to not call the police.

The suspects are described as follows:

(1) B/M, late teens to early 20s, 5'7, 150 lbs., thin, and black hair

(2) B/M, late teens to early 20s, 5'4, 140 lbs., and black hair.

Surveillance video from business showed a newer Black Dodge Durango pulled into the parking lot from S/B Lahser. The vehicle backed up to the double doors of the store. One suspect exited the vehicle and hooked a rope & chain to the store doors. A second suspect also exited the vehicle. The vehicle pulled forward and tore the two front doors off of the store.

Three suspects entered the store and ran straight towards the ATM located in the store. The fourth suspect (driver) unhooked the rope/chain from the doors while the other suspects stole the ATM. The three suspects inside the store dragged the ATM out of the store and loaded it into the trunk of the Durango.
