


Officers arrived on scene and spoke to the victim. Victim (R/P) states she and her friend were smoking outside their room when a male who was staggering by the stairs and pacing back and forth asked the victims for a cigarette.

When the victims stated they didn't have a cigarette the subject forced his way into victim's room.

The suspect sexually assaulted one of the females and when the victims refused to give suspect their passwords for their cell phones he smashed both phones. The suspect opened the dressers and went through victim's bags, but did not take anything. The suspect eventually left the room.

The clerk at the front desk stated he received a call from victim's room stating a B/M wearing a red hoodie just broke into their rooms and broke their phones and assaulted them. The victim on the phone said the male left and got into a black car.

On 06/07/2019, Southfield Police Officers were dispatched to the 27000 Block of Northwestern Hwy (Hotel) for a Domestic Assault in progress. When Officers arrived on scene the male suspect fled on foot from Officers. The male suspect was last seen running across Telegraph Rd. towards a Car Dealership.

As Officers were searching the lot at the dealership they observed suspect hiding underneath a vehicle. Officers identified themselves and advised suspect to come out from under the vehicle. The suspect complied and he was arrested for Resisting & Obstructing Officers. After the suspect was taken into custody Officers were advised by employee at the dealership that there was a handgun under one of their vehicles where the suspect was taken into custody. Officer reviewed surveillance video from the dealership and observed

officer reviewed surveillance video from the dealership and observed suspect throwing something under the vehicle where the handgun was recovered from. Suspect was also charged with CCW.

A Southfield Police Evidence Technician collected & preserved the handgun for evidence.

W Ten Mile Rd. & Fairfax St.

On 06/07/2019, Officers responded to the area of W Ten Mile Rd and Fairfax St for an incident regarding a possible kidnaping and assault. Female victim was located and stated she was assaulted by her grandson's father and his mother. Victim had multiple broken and bloodied finger nails, she was uncooperative with Officers, hysterical and refused medical treatment.

Further investigation led to the arrest of female suspect for A&B. During the incident and after Officers arrived on scene and were conducting their investigation, suspects son and his friend, arrived on scene in a White Dodge Durango. Both subjects immediately started posturing like they were going to assault one of the witnesses. Officers had to stand their ground and stop subjects from assaulting the witness. Both subjects were loud, disorderly, causing a disturbance and were uncooperative telling Officers what to do.

Both subjects were taken into custody for disorderly conduct and R&O.

OWI/ R&O- 1- Arrest

Southfield Rd. & George Washington

On 06/09/19 at approx. 0309 hrs., Officer was dispatched to Southfield and George Washington Dr. on a report of a vehicle that fled from an accident on M-10. (MSP was responding to this accident.)

Dispatch advised the suspect vehicle was a Dodge Charger and put out the license plate #. Dispatch also advised Officers the Charger was being followed by citizens that observed the accident. The charger became disabled and stopped at Southfield Rd and George Washington.

Upon arrival, Officer observed a Red Dodge Charger with license plate that was given out earlier parked partially on the curb at Southfield and George Washington. The Charger had fresh front end damage and the left front tire was missing from the vehicle. There were approx. 5-7 other vehicles stopped near the Charger. There were multiple people outside near the crashed Charger and they were all pointing at the driver of the vehicle who was standing within the group of people arguing with them. When Officer attempted to speak with subject and get him away from the citizens he was uncooperative and ignored Officers direction.

Because of the suspects hostility towards the witnesses, Officer grabbed onto subject's arm and told him to step away from the crowd so he could speak with him. The suspect tensed his body up and ripped his arm away from Officer. He then grabbed onto Officers bullet proof exterior vest. Officer took the subject to the ground where subject continued to resist Officer. An off-duty Officer from another jurisdiction who was a witness to accident assisted Officer getting suspect secured & handcuffed.

Additional Officers arrived on scene and the scene was secured. Witness observed suspect crash at Southfield and George Washington.

He observed suspect get out of the driver's seat of the Dodge Charger and argue with a driver in a white pickup who was also following suspect. Witness heard the driver of the white pickup accuse suspect of causing a major crash on M-10.

Two additional witnesses advised they witnessed the accident on the freeway. (M-10 & 7 Mile Rd.) They witnessed suspects Red Charger driving recklessly in and out of lanes strike a truck causing the truck to roll over multiple times. Suspect veered into a concrete barrier after striking the truck and proceeded to leave the scene of the accident. Witnesses followed suspect to Southfield Rd. & George Washington in Southfield where the vehicle lost a tire and became disabled.

The suspect was arrested for OWI & R&O.
