


# **Be on the Look Out Highlights:**

Special Attention: Wheels & Tires/ Hubcaps Stolen this Past Week:

1)15000 Block of Providence Dr.

(Residential- Apartments)

All Four hubcaps were stolen from victims 2015 Chevy Impala.

2) 16000 Block of Templar Cir.

(Residential)

All Four Wheels & Tires were taken from 2017 Ford Escape.

Officers attempted to identify the other occupants of the vehicle. One of the occupants was looking around and appeared to be very nervous. It was later determined that this subject had given false information about his identity. His true identity revealed that he had a Felony Warrant out of neighboring jurisdiction for a concealed weapon charge.

The driver of vehicle was arrested for Possession of Marijuana and the passenger that gave Officers an alias name was arrested for Obstructing Police Officer & Felony Warrant.

(Bar/ Lounge Establishment)

On 03/26/2017 at 11:56pm, Southfield Officers were travelling S/B M- 10 near Lahser when they observed Silver Chrysler 200 with Improper Plates on vehicle. Officers initiated a stop for an improper plate and the vehicle stopped on S/B M-10 near the entrance to E/B I-696.

Officers approached the vehicle and observed a bullet hole in the top left corner of the driver's door. They observed a missing, broken driver's window and also a spent bullet on the floor mat in front of the driver's seat. It appeared the bullet was shot into the vehicle.

All of the occupants were removed from the vehicle and interviewed. Investigation revealed that the subjects were at a Lounge Establishment in the 12 Mile & Northwestern area of Southfield and they were refused entry into the lounge.

After being refused entry into the lounge a large group of people came out of the lounge and they all started fighting. One of the subjects was overheard saying "Go Grab It".

They knew what that meant. (Go get a gun)

They all ran to their vehicle. Gunshots could be heard as they entered their vehicle and one of the vehicles window was broken out.

No one was shot or injured in the incident.
