Victim stated he was visiting his grandfather at location when suspect (mother) came over to take 5 month old child they have in common. Victim wouldn't let mother into grandfather's apartment. Victim had the door locked with the chain on. Suspect (mother) proceeded to kick the door in causing damage to the door frame. Once suspect was inside the apartment, victim freely handed over child to suspect and he left with the child. Officers observed that the door frame was split, and half of the jamb was lying on the floor inside the apartment. Suspect has been identified and incident is under investigation.

Suspect has been identified and incident is under investigation.
