


Victim hit the access button to unlock the front door and the subject walked to the counter to the right.</p> <p>The subject immediately announced that it was a Robbery. At this point and now closer to the subject victim could tell the subject was a man and not a woman based on the subjects voice and looks. The subject immediately walked behind the counter forcing open the locked half door and back to the rear of the business with victim. The subject removed all the cash that was in the cash boxes within the safe that was open. An undisclosed amount of cash was taken.</p> <p>The subject zip tied victim's wrists to the front and told her to stay in the bathroom until he left. After locating the subject he advised that he had been robbed and stabbed while walking outside to go to the store. Victim's girlfriend told Officers that her boyfriend left the apartment and came back up 20 minutes later bleeding and saying that someone stabbed him. Victim's girlfriend advised that she and victim were drinking last night but nothing happened between them. Officer's investigation determined that it was most likely that the girlfriend was the one that stabbed her boyfriend. There was no blood found in the area of where the victim stated he was robbed and stabbed. The only blood that was found was inside the victim's apartment. Officers later went to the hospital to speak with the victim. Officers were able to illicit the truth from victim. Victim stated that he met another woman at the bar and brought the women home to his apartment. Victim's girlfriend wasn't supposed to be there. Officers were dispatched to the 23000 Block of Lahser on report of a Domestic Situation. During this investigation several additional Officers were called to the scene.

Officers were met at the door by victim/girlfriend of suspect who stepped out onto the porch and pleaded for Officers to leave, stating that suspect had just left. Victim was observed to have injuries, and she was visibly upset and crying.

During the remainder of this investigation, victim provided a vague statement, and refused to cooperate. (Most likely because she feared her boyfriend)

Prior to entering the home, Officers could see through a window and observed that the suspect was still there. He was overheard directing a

small child to close the door on Officers and to lock the door, which the child did.

Officers also received information from dispatch, that suspect had several warrants.

Suspect eventually opened up the door, and he was arrested for the outstanding warrants. He was searched, and was found to be in possession of several gun parts that were in his pockets. He also admitted that he was a felon.

Officers spoke with several children & adults that were in the home. They all stated that the suspect had a gun and threatened them with it. They stated he took it upstairs when the Police arrived.

During the investigation Officers prepared a search warrant for the residence. During the execution of the search warrant Officers located several parts to the gun and it appears that the suspect disassembled the gun when he saw the police were there.

The suspect was arrested at this time for F/A and the outstanding warrants.
