



Note: This incident and the incident that occurred above, appear to be the same suspect. In the Special Attention Section at the end of this report there is suspect information from City of Farmington that had a similar incident in their city. 

R/P opened the interior door but not the storm door. R/P walked away from the door to put on a pair of pants and that was when her ex-boyfriend kicked out the lower glass portion of the exterior front door. He then reached into the door and unlocked it and entered the residence. R/P gave her ex-boyfriend his jacket and asked for her cell phone back. He said no and fled because R/P called the police. R/P states on a previous date, 11/03/2020 her ex-boyfriend came to her residence and was allowed into the residence. When it was time for him to go though, he refused to leave. Colonial Oil Change 11/05/2020 3:00am 30000 Block of 9 Mile Rd (Commercial- Oil Change) Suspect(s): Black Male Suspect Vehicle: Late 90s Dark Colored 4 Door Sedan. On Thursday, November 5th, 2020 at 3:00am, a B/M suspect broke into Colonial Oil Change in Farmington City. The suspect threw a brick through one of the bay door windows. The suspect stole the cash register and 2 Samsung Galaxy tablets. Video shows the suspect vehicle leave east bound on 9 Mile from the scene. Appears that this suspect is the same suspect that broke into two Oil Change businesses in Southfield. See Photo's Below:	27000 Block of Northwestern Hwy. (Hotel) Officer observed vehicle exiting Hotel in the 27000 Block of Northwestern Hwy. The vehicle was occupied by three subjects. Officer observed traffic violation and turned around to follow vehicle. The vehicle sped up and went through a Car Dealership at a high rate of speed. (Vehicle appeared to be attempting to avoid Officer) The vehicle then pulled back out onto Northwestern Ser. Dr. and then turned back into the Hotel. Officer ran the plate attached to vehicle and it came back through Lein that the registered owner had a Suspended Driver's License. As the vehicle pulled into the Hotel it almost struck another vehicle. Due to traffic violations, suspicious behavior and the vehicle attempting to avoid police the vehicle was stopped. Additional Officers assisted Officer with the stop & investigation. After contact was made with the driver he was acting very nervous, was uncooperative and couldn't explain why he was trying to avoid Officer. It was confirmed that the driver had a suspended license and he was taken into custody for DWLS. The two female passengers exited the vehicle and were released from the scene. During the inventory search of the vehicle Officers located a handgun under the front driver's seat. Officers also located a box of ammo for handgun in the glovebox. The driver didn't have a CPL and was also charged with CCW.

Fraud/ Illegal Use of a Credit Card- 1- Arrest 11/05/2020 1:00pm

19000 Block of Eight Mile Rd.

(Household Goods & Material Distributors)

A subject used a stolen credit card on 11/04/2020 to purchase merchandise from business. On 11/05/2020 the subject came back and attempted to make another purchase. TCSU Officers contacted the suspect and detained him while other Officers investigated further.

Officer contacted the card holder and he confirmed that his credit card was being used fraudulently. Employee that performed the sales transaction positively identified the suspect that Officers had detained as the suspect that used the credit card twice to purchase items fraudulently. The suspect was taken into custody.

Special Attention/ MDOP City Hall City Property Graffiti Spray Painted on City Buildings.

11/03/2020 4:26am 26000 Evergreen Rd.

(Southfield Municipal Complex)

On 11/03/2020, Officers responded to the Southfield City Hall regarding the glass on the front doors of city hall were spray painted, red in color, and that the paint was still tacky. It was later discovered the north side of the building near the Parks and Recreation entrance was also spray painted. When this paint was discovered it was also still tacky.

The wording that was written on the buildings was unusual and the meaning behind it is still being investigated.

Note: Officer observed a possible suspect of the MDOP of City Hall in the parking lot of Office Building in the 26000 Block of Central Park. Officer observed a black male wearing a backpack and what looked to be a brownish hat with his hood over it. The subject quickly turned away from Officers patrol vehicle as he cut through the parking lot.

Officer lost sight of suspect as he turned in his direction and the suspect wasn't located.

It's believed the suspect jumped over the wall leading to the Knob in the Wood Apartments. Further area check was conducted in the area by several patrol units but subject was not found.

Fleeing & Eluding- 2- Arrests

11/02/2020 4:15am 26000 Block of Telegraph Rd. (Hotel)

Officer observed two cars parked in the parking lot that had fled from him earlier. The cars were in the parking lot of Hotel in the 26000 Block of Telegraph Rd. The drivers of the cars were not located at first and the vehicles were being impounded by Officers. During the impound of the vehicles the drivers came out and spoke with officers. Both drivers made admissions/ statements placing them behind the wheel of the vehicles when they fled from Officers. Both suspects were taken into custody for Fleeing and Eluding. A Southfield Police Evidence Technician took photos of the Graffiti.

Surveillance Video shows the suspect walking adjacent to the city buildings. The suspect is the same as two previous incidents, wearing the same clothing and backpack.

Traffic Crash/ OUIN Investigation-1- Arrest11/05/2020 7:24amSouthfield & Mt. Vernon

Officer responded to a roll-over crash. The female driver had multiple non-life-threatening injuries. Officer contacted the driver and she exhibited signs of intoxication. The female driver made admissions to consuming alcohol, smoking marijuana and taking ecstasy pills prior to the accident. The driver was taken to the hospital for treatment and further evaluation. A blood draw was conducted and the female was released to medical personnel pending results of toxicology report.

Special Attention: MDOP/ Graffiti Spray Painted on City of Southfield Library

26000 Block of Evergreen Rd.

(City of Southfield Public Library)

A Southfield Police Evidence Technician responded to the City Public Library regarding a report of a MDOP. Upon arrival Officer spoke to librarian at the location. R/P states she arrived at library on 11/03/2020 and found person/s unknown had spray painted graffiti on the exterior of a glass door and windows leading into the garden area.

Officer observed the graffiti, red spray paint was used and the words "soft foot shakur" and SK was written. Officer took photos of the graffiti. Southfield Detectives extracted surveillance video from the library. Suspect was observed on Camera at 2:30am on 11/03/2020 through 2:50am. This is the same suspect that is responsible for other MDOP's within the municipal complex.

Special Attention: Graffiti painted on Front Glass Doors at US Post Office.

11/03/2020 12:38am 22000 Block of W Eleven Mile Rd.

(US Postal Office)

Officers were dispatched to the 22000 Block of W. Eleven Mile Rd. (US Post Office) for a report of MDOP. R/P advised he observed graffiti on the front glass/doors of the post office while he was there checking his PO Box.

Officers observed red spray paint that read "NONE OF THE ABOVE S.K" on the front glass doors of the building. Officers conducted an area check for the suspect with negative results.

Note: This appears to be the work of the same suspect that has been spray painting graffiti on buildings at Southfield Municipal Complex.

Special Attention- Reckless Driving/ MDOP

11/03/2020 6:19pm

10000 Block of Towne Square

(Parking Structure)

On 11/05/2020, Officer met with the R/P (Property Manager) for follow up regarding Reckless Driving/ MDOP Complaint.

R/P advises he had multiple vehicles on the top deck of his parking structure doing "doughnuts" and speeding throughout the structure on 11/03/2020 around 7:30pm. His concern was for the safety of the individuals as well as his employees that work in the building. R/P expressed concerns that when the 3 vehicles drove into his parking structure, he had an employee that was almost struck by one of the vehicles.

Officer observed multiple tire markings on the top floor of the parking structure consistent with when a vehicle conducts "burn outs" and "doughnuts". The markings were photographed by SPD Evidence Technician.

R/P showed Officer video of the incident on 11/03/2020. Officer observed 3 vehicles on the top portion of the parking deck. The video showed one of the vehicles speeding and doing "doughnuts" on the structure. R/P advises all three vehicles were driving recklessly on his property and created markings all over his new parking structure. **Note:** On the original Complaint that occurred on 11/03/2020, Officer investigating contacted one of the individuals. The individual was a younger lightskinned black male approx. 20-25 YOA. The license plate on the vehicle was run via LEIN and came back to a 2011 Chrysler 300. The individuals were advised they were not permitted to be on the property and they left without incident. The owner of the vehicle was added to report for further investigation. The other two vehicles appear to be unknown 4 door sedans dark in color.
