

## **Special Attention:**

Larceny of Packages that were ordered and delivered via Common Carrier. How to prevent this from happening to you!

Recently several citizens have had packages that were delivered to their residences and apartments stolen prior to them retrieving the packages. Citizens can prevent this from happening by scheduling a specific time to have the package delivered and be waiting for the package. Citizen can also schedule the package to be picked up by themselves at the common carrier facility.

# CCW/ Possession of Handgun with altered Serial #.

Southfield Officers responded to Domestic, possible subject with a handgun at residence.

Officers arrived and located suspect and his girlfriend attempting to flee through the back yard. Both subjects complied when ordered to stop.

Investigation revealed that R/P had asked her son (suspect) to leave her residence after discovering that he had snuck his girlfriend into the home. R/P also stated she had observed suspect with a handgun. Officers patted suspect down and discovered several rounds of ammo in one of his pockets.

Officers searched the immediate area and located the handgun in the back yard where the suspect and his girlfriend were observed walking away from the residence.

Inspection of the handgun revealed that the serial# had been altered. The suspect was arrested for CCW & Possession of Firearm with Altered Serial #.

Special Attention: LFA's

Special Attention: Larceny from Vehicles How to prevent this from happening to you!

- -Citizens should never leave anything of value inside their vehicle. (Especially Handguns, Purses, Wallets, Cash & Cell Phones!)
- If you have a garage you should park your vehicle in the garage and lock the garage.
- Wheel Locks are a deterrent but don't leave the wheel lock key in the interior of your vehicle, especially the center console or glove box. This is the first place they will look for the wheel lock.
- -After parking your vehicle turn your wheels all the way to the right or the left. This will make it difficult to get the lug nuts off the front wheels.
- -If you don't have a garage, try to park your vehicle as close to your residence as possible.
- -If you here any loud noises near where your vehicle is parked, especially during the late night or early morning hours, attempt to look outside without alerting anyone and if someone is tampering with your vehicle immediately call 911, (Do Not Approach

Southfield Officers assisted another agency with a traffic stop of a vehicle. The traffic stop was conducted w/o incident.

After approaching the vehicle and asking the driver for his license, registration & insurance the driver opened the glove box and in plain view were two loaded magazines for a handgun.

The driver at this point made admissions that he had an unloaded handgun, boxed in the rear compartment of the vehicle.

Officer attempted to stop vehicle for No Headlights.

All of the suspects were processed and lodged at the Southfield Jail.

# NOLOP/ Possession of Crack Cocaine, Marijuana &

### Hash- 1- Arrest

12/03/2017 2:33am

Eight Mile Rd. & Inkster Rd.

Officers were on routine patrol when they observed what appeared to be a drug transaction in a parking lot in the 22000 Block of Eight Mile. After the two vehicles and subject on foot parted, the suspect vehicle crossed over 8 Mile Rd. and went w/b on 8 Mile Rd.

Officers followed the vehicle and ran the plate on vehicle. The plate came back expired and the vehicle was travelling in excess of the posted speed limit.

A traffic stop was initiated by Officers and the vehicle was stopped N/B Inkster Rd just north of 8 Mile Rd.

Officers investigation revealed that the driver was NOLOP and there was a clear bottle in plain view that appeared to have suspected marijuana and Hashish inside.

Both occupants stated they didn't have a marijuana card.

Further search of the vehicle Officers located a plastic baggie with suspected Crack Cocaine in it.

A Southfield Police Evidence Technician Field Tested the suspected Marijuana, Hash and Crack Cocaine. All three came back positive for possible presence of Marijuana, Hash & Crack Cocaine.

The driver of the vehicle admitted that the drugs were his and he was arrested for Possession of all the substances and NOLOP.
