



On 10/27/2020 around 3:19pm, Officer advised he had an occupied stolen vehicle in the 25000 Block of Northwestern (Hotel). The vehicle was occupied by two black males and was making its way towards the north exit of the hotel parking lot. The vehicle pulled under the awning by the hotel front doors as Officer was activating his emergency lights. Additional Officers pulled into the complex as Officer was approaching the stolen vehicle. The driver of the vehicle exited the car and ran into the hotel. Officers pursued the suspect. Video surveillance showed the suspect run up to the third floor where he entered a hotel room. Officers went up to the third floor of the hotel where they contacted a citizen walking down the hallway towards the elevator. The citizen approached Officers and stated there is an unknown male hiding in his room who he does not know. He said he left his room to go get ice and left his door ajar. He said when he returned, he found a male hiding in his hotel room, telling him to be quiet. The citizen also said he left his girlfriend, in the bedroom who was unclothed. Officers entered the citizens hotel room and observed the male hiding behind the bathroom door and called the suspect out. The suspect walked out of the bathroom and was taken into custody for R&O and Unlawful Entry into citizens Hotel Room. Vehicle was confirmed stolen.

Further investigation it was discovered that the victim was at the station to make a report regarding incident. She returned to the scene and met with Officers. R/P advises that her sister, and her boyfriend, are the two individuals that kicked in her door. R/P was not at her apartment when the incident occurred. She had received information that the two suspects were at her apartment because her sister wanted to get her daughter back. R/P informed Officers that she and other family members have been caring for her sisters 13- year old daughter. Allegations of child abuse have been made against her sister for her children and she had a meeting with CPS tomorrow regarding this alleged abuse. R/P thinks that her sister kicked her door in, because she wanted to get her daughter and take her with her out of state. The daughter is currently safe and staying
