

An area check was conducted with negative results. During the area check for suspect it was reported that two local jurisdictions had similar incidents in their cities.

Investigation revealed that after the crash which occurred at 12 Mile &amp; Telegraph, both vehicles pulled into the parking lot at Leasing Business. One of the drivers opened the other driver's car door and demanded cash for damages to her vehicle. The other driver refused payment stating Michigan is a No Fault State. Suspect then threw a cup of water on victim and attempted to take her purse. Victim held onto her purse as suspect continued pulling victim by the hair from the vehicle and then throwing her to the ground. At some point witnesses from Leasing Business came to victim's aid and brought her into the business to wait for PD. During PD Investigation suspect made admissions to the assault and stated she suffers from anxiety attacks. Suspect then passed out and fell to the ground. Life Support transported suspect to Hospital where she was RPI'd. Suspect has been identified and incident is under investigation.</p>
