He also informed the Board of the recently announced change at World Asset Management (WAM); Comerica had contracted with Yousif Capital Management (YCM) to sub-advise the WAM funds, including the Retirement System's S&P 500 Index fund. As part of this change, YCM will be employing several employees of WAM to help with the management of these funds. He informed the Board that AndCo currently works with YCM, but will need to review any changes to the fee structure with WAM and Comerica that may result from this change.
