RESTAURANT TECHNOLOGY & PPE REIMBURSEMENT PROGRAM

STATEMENT OF PURPOSE

The Restaurant Technology & PPE Reimbursement Program is a grant based initiative available to qualifying restaurants, bars & cafes within the City of Southfield. The purpose of this program is to reimburse eligible businesses for: 1) products purchased to support dine-in restaurants, bars & cafes impacted by COVID-19 and related public health orders and 2) Provide products, supplies and services to assist in operating safely and in re-opening, when allowed. This is a companion grant with the Restaurant Weatherization Program. The maximum total reimbursement for both the Weatherization and Technology & PPE for a single business is \$10,000.

PROGRAM FUNDING & ELIGIBITLY

This program is administered through the department of Business & Economic Development Department. Complete the Technology & PPE application to seek reimbursement for eligible items.

Eligibility:

- Eligibility will be limited to full-service and limited service restaurants, breweries and cafes. The following establishments are not eligible, based on Oakland County requirements:
 - Establishments with drive-thru availability
 - Establishments with zero or limited dine-in presences and/or whose primary operation appears to be take-out and delivery
 - Establishments that were determined as being permanently closed

Items eligible for reimbursement include:

Technology related items, such as, but not limited to:

- Upgrade websites/install apps for online ordering or delivery
- Install point-of-sales systems to minimize employee-customer contact

General Personal Protective Equipment (PPE) and Supplies, such as, but not limited to:

- Electrostatic sprayers and disinfectant solution
- Sanitation Stations
- Refill wipes and liquid hand sanitizer
- Foot operated door pulls
- Design and Permit Fees related to reopening

The conditions dictating eligibility are outlined as follows:

- 1. The property owner must present proof of ownership of the building in question or a notarized letter of consent from the property owner confirming agreement regarding the proposed outdoor dining, if applicable.
- 2. The applicant must submit documentation of outside dining approval by the City of Southfield Planning Department. In accordance with City Resolution C-04-2021 or prior approval with Southfield Planning Department.
- 3. The applicant must provide receipts/proof of payment for the work completed within designated timeframe July 1, 2020 through June 30, 2021.
- 4. Eligibility will be limited to restaurants open or planned to open for outdoor dining within the period of availability. If the business is not currently open for outdoor dining the application should state the estimated open date, if applicable.
- 5. Application must include detail of eligible expenses already incurred or a detailed description of planned eligible expenses.
- 6. Proof of expenses incurred (receipts/invoices and proof of payment) along with a picture of the items to be reimbursed shall be submitted before any request for reimbursement will be approved.

STEPS AND PROCEDURE

- 1. Property owner or tenant completes application and submits all necessary documentation as stipulated above.
- 2. Restaurant Technology & PPE Reimbursement Program Review Board reviews the application to verify that the property in question is good standing regarding all applicable property taxes and zoning ordinances. This review will also include a verification that the outdoor dining area meets current Planning, Building and Fire Codes.
- 3. Upon approval, the applicant will be contacted by the Business & Economic Development Director and instructed of next steps.

CONDITIONS

 Any non-compliance regarding planning, building and fire codes and zoning violations must be rectified prior to the applicant's submission of paid receipts for reimbursement review.

- All items must be used for outdoor dining at the specific location as designated on the application. If items are not used as described in the application, the City reserves the right to deny reimbursement and seek repayment.
- All applications must be substantially complete, with necessary document.
- Funding is strictly for reimbursement for items identified in eligibility criteria.
- All City of Southfield taxes and fees are paid or current.
- Failure to respond in a timely fashion to requests for information or completion of requests may disqualify your application.
- Any non-compliance regarding planning, building and fire codes and zoning violations must be rectified prior to the applicant's submission of paid receipts for reimbursement review.
- Salary or wages of employees of restaurants, bars and cafes are <u>not</u> eligible for reimbursement.
- Applications will be ranked based on first come first serve basis of applications received during the open application timeframe of March 1 March 31, 2021.
